### **Planting Time**

Winter is our planting season and 2013 has been a busy time for our group. We started off with a Friends planting near Crosby Drive on Sunday 7<sup>th</sup> July when we planted 1300 tube-stock plants on a good sunny morning.

This was followed up with a planting with volunteers from the Novotel Group the following Thursday 11<sup>th.</sup> July when a further 1400 tube-stock plants were planted in the same area. We planted out what had been a very weedy area near Crosby Drive and it now looks much more attractive.

National Tree Day on Sunday 28<sup>th</sup> July was our big planting event of the year. We had cloudy but dry weather for the 75 volunteers who planted 7530 tube-stock plants in Fairway Reserve downstream from our NTD site for last year. The scouts put on the usual tasty BBQ for the hungry volunteers.

This was followed up with 18 volunteers from United Energy the following Friday 2<sup>nd.</sup> August when a further 1500 tube-stock plants were planted in the same area by Scotchmans Creek.

Our Melbourne Water grants paid for 10,000 plants this year. This makes a real difference to the vegetation beside our creek. We have been fortunate with rain after nearly every planting session which should help to ensure that a high percentage of plants survive.

I want to thank all the Monash "bush crew" for their work in preparing the ground before hand and in helping to distribute the plants on the day.



#### **Remembering Tom Morrissey**

As part of our National Tree Day event we took part in a tree planting ceremony when Mrs. Morrissey planted a yellow box sapling in memory of Cr. Tom Morrissey. A plaque and a seat will be installed near the tree. Monash Mayor, Cr. Drieberg and other members of the Morrissey family attended the ceremony.

#### July

### **Monthly Water Quality tests**

Creek flows were higher than usual, following the overnight rain. Water was flowing through the wetlands by overflowing the first weir and the blocked inlet control pit.

Most indicators were Fair to Excellent, except for high turbidity at all sites (Degraded rating) and a Degraded phosphorus rating at the Regent St. site.

#### **Annual Habitat Assessment**

All the upstream sites retained their overall Fair ratings from 2012, but some details were rated lower.

Bank vegetation has been thinned at Site 1a (Fiander arm) possibly by weed removal, but this exposes some ongoing spot erosion.

Also at site 1a, sand washing into the stream bed is inhibiting the in-stream

vegetation and clogging the riffles.

P=Poor

In the upstream wetlands pond (site 4) the banks are thickly covered with reeds which get forced aside by flood events, resulting in unsightly banks and difficult access to the pond.

D=Degraded

### August

The chemical results were as usual – most indicators fair or better, but conductivity poor in the Fiander arm and phosphorus level poor in both the Fiander and Crosby arms.

The wetlands showed signs of recent flows in and out, but there was no flow at the time of this site visit.

Sand and stones washed into the creeks was getting worse. At the upstream sites it was smothering the stream bed vegetation and forming large mounds which may impede the water flow. This material remains mobile and may move

and cause similar problems downstream (in addition to the existing blockage of the wetlands inlet pit).

There was a lot of litter in the stream bed, on the banks and in the vegetation at the upstream sites, and in the upper parts of the wetlands. There was a lot of litter floating on the pool just downstream of the litter trap at the join of the Crosby and Fiander arms. (A litter patrol by Holmesglen TAFE students, the day following this site visit, cleared about 15 kg of litter from the creek banks of the Crosby arm upstream of site 1b).

There was a large area (50 sq m) of a milky / waxy scum on the pool in Scotchmans Creek at Regent St (YSC020, Site 2). A similar scum was seen in the Crosby arm (Glen Waverley Drain) where it emerges from the underground drainpipes at Waverley Road.

#### **Vegetation Protection - Amendment C115**

(Quote from Monash City Council website)

"In early 2013, Council sought community feedback on proposed changes to Monash's Vegetation Protection Overlay. The proposed changes were aimed at making it easier for landowners to remove significant trees. The changes were put forward as Amendment C115 to the Monash Planning Scheme.

Council received 391 submissions from the community about the proposed changes. At its April 2013 meeting, Council decided to refer the submissions to an independent Review Panel for consideration. The Panel considered all written submissions and also considered verbal submissions made at hearings held at the Monash Civic Centre in June. In mid-August, Council received the Panel's report.

In summary, the Panel recommends that the **Amendment be abandoned** and that the existing VPO be retained. The Panel also recommends

Council undertake additional work to "better determine vegetation values (with expert and community input) and to review planning policies as part of an integrated approach towards vegetation protection and management".

Council will consider the Panel report and decide on its response at its September Council meeting. Council has three options:

- to abandon the Amendment
- to proceed with the Amendment (which would require final approval by the State Planning Minister) or
- to investigate possible changes to the Amendment."

In the Overall Conclusions section of its report, the Planning Panel stated:

"The Amendment is fatally flawed in the view of the Panel because it is not supported by any strategic investigation of the vegetation and what its values and purpose for Monash is or what role the planning scheme should have in managing vegetation in a strategic sense.

The drafting of the Amendment with the permit exemptions is viewed by the Panel as creating a vacuum whereby removal of canopy trees can occur for a range of reasons without any opportunity for Council to consider the broader landscape context of any removal or cumulative effects of multiple or consecutive removals.

The Panel found that the proposed Amendment was poorly and inconsistently drafted, provided no effective protection for any vegetation in Monash or adequate recognition of its intrinsic values to the community, and was criticised by government agencies and many members of the community...

...In this report, the Panel has made reference to Council reviewing the VPO1, in conjunction with the planning scheme generally, with regards to vegetation management and considers the Council should take into consideration not only landscape and neighbourhood character issues but other environmental values that many submitters highlighted during the Panel Hearing.

It is for these reasons that the Panel concludes that Amendment C115 is not appropriate and should be abandoned."

The Council will consider the Panel Report at the meeting on 24 September 2013. All members are urged to attend to give Council an indication of community interest and the value placed on the Vegetation Protection Overlay.
