## President's Report

Monash Council has prepared a draft 'Mount Waverley Activity Centre Structure Plan' which is on their web site, and which you can download. There is an online survey which I would encourage all FSCVR members to complete – have your say!

Our involvement will be led by our Vice-President, Kallista Sears, who will be attending a workshop next week representing FSCVR. She will be working to put together a formal response from FSCVR as a concerned community group.

We have noticed that there are proposals in the draft plan that could result in cycle paths running through Valley reserve. We believe that the focus of Valley Reserve is firmly as a bushland conservation resource, and we will be making the point that any increase in the volume of cyclists in the reserve is not compatible with that focus.

If you agree, then please take the time to respond to Monash Council's invitations to comment. We need to make our views clearly known.

Following up on the success of the 'State of the River' report, we have decided to create a companion 'State of Valley Reserve' report. Kallista will be working on this over the next few months, assisted by other committee members. We will be inviting your input and comments to help us compile the report, and I will ask Kallista to give us a progress summary in the next newsletter.

Hope to see you all at a planting, weeding or public event over the next few months.

# Report from our River Officer

Hello. I have recently replaced Carlie Dann as the Friends "River Officer". Carlie has done an excellent job over the past few years and we thank her for her excellent work in this – including introducing some valued initiatives she has carried out in this role.

The River Officer is responsible for undertaking, on a regular basis, visual inspection of the condition of the waterway and banks of Scotchmans Creek. Observations are reported to the Committee on a quarterly basis and this regular report, together with the results from the Waterwatch Program formed the basis of the State of the River Report prepared by Carlie, Tony Walker and Fred Bullock, distributed to Council and Melbourne Water in April this year and presented to the Friends membership at our May meeting.

Following on from the report the most recent inspection of the creek was undertaken in early May. Our summer has been dry but the inspection closely followed some moderate, but very welcome, rainfall.

Grasses (including weeds) on the banks have come to life. In some locations there is evidence through flattened grasses that water levels in the stream and wetlands were temporarily high and brought with them unfortunately a moderate level of debris including litter. However, bank conditions are relatively stable with little evidence of enhanced erosion or damage to vegetation.

Visually water quality looked fine in both wetlands and stream and re-vegetation planting looked undamaged. There is however evidence that the significant dry period over last year have left moderate sized trees and shrubs under stress. The wetland area continues to have a mixed quality



of vegetation and it is the Friends intention to seek improvements in this area. It is interesting to compare the quality of vegetation at Lawrence Road bridge with that downstream near Huntingdale Road Wetlands.

Nevertheless there are some really pleasing stretches of the stream that reflect well on past efforts for improvement as per this recent photograph.

On our walk we noted several different bird species

(including water and land birds) and frogs were vocal. It was also pleasing to see many walkers and riders of different age and sizes. It was dis-appointing though to see some dogs on and offlease in clearly inappropriate places.

#### **April**

- Rainfall has been low and the creek flows are still low, resulting in some poor chemical ratings...
  - Degraded oxygen and phosphorus levels at site 1b.
  - o Degraded turbidity levels at sites 2, 3.
  - Otherwise Fair to Excellent ratings.
- In-stream vegetation is improving at site 1b (Glen Waverley Drain). However the invertebrate samples at both upstream sites (1a, 1b) had low variety and rated Poor.
- We glimpsed a goldfish at site 1a disturbed by our waterbug netting activity but quickly escaping.

#### May

- The physical and chemical results were Fair to Excellent, except that Valley Creek (at a trickle) was muddy (Poor turbidity measurement).
- There was only a small team available, so the scheduled waterbug sampling was not done. A
  waterbug sample taken from site 2, for a school excursion 3 days before, had low variety and
  abundance.
