## ***Planting Program for 2020 and 2021***

Due to the COVID-19 restrictions our planting program for 2020 was carried out by the Monash bush crew. We thank them for their assistance with this. So far the plants are growing well, especially the ones next to Regent Street.

We are starting to put in grant applications for more plants to be planted in 2021. We have been successful with our grant applications over many years and are grateful to Melbourne Water for their continued support.

## ***Pesticide Detectives***

This was a national Citizen Science project run by AQUEST and RMIT University, investigating the occurrence and concentrations of pesticides (insecticides, herbicides and fungicides) in Australia's waterways, mostly in rural areas. Our 2 urban site nominations, at Huntingdale Rd Wetlands and at the join of Valley Creek and Scotchmans Creek, were accepted in the last round (round 4) and in early April we collected sediment samples to be analysed by a specialist laboratory.

Results were published recently - see <https://pesticidedetectives.com.au/>. Pesticides were detected at 16 of the 87 national sites in round 4. Of those, 8 were in urban areas, and 2 were on Scotchmans Creek, where the insecticides Bifenthrin and Fenvalerate and fungicide Propiconazole were detected. The project scientists note that the Bifenthrin concentrations may pose a risk to freshwater crustaceans and suggest that further testing is required. Note that some other sites had much higher concentrations and have greater economic importance, so they presumably will take priority.

## ***Cub Scouts at Scotchmans Creek***

This year we have not been able to assist the local schools with their conservation programs due to Covid-19. But in November with restrictions easing we were able to introduce some small


groups of cub scouts to Scotchmans Creek in Fairway Reserve. We talked about the creek and its importance to the environment and the local birds and animals. We explained about the issues with storm water and litter and helped the scouts pick up litter near the scout huts.

We hope to return to our usual program with the local schools in 2021 as they are very popular in helping the schools complete their programs

### ***Parrots Feather – an aquatic weed.***

From time to time we get an infestation of Parrots Feather in the wetlands. When we see it we let Melbourne Water know and they remove it as soon as they are able.


Recently I noticed Parrots Feather in a small lake in Templestowe in a photo I was sent. Melbourne Water are arranging for Manningham Council to remove it.
